### **Corporate Documents Required**

We require Corporate Documents for the company that is opening an Account in Belize. The Corporate Documents must be notarised or apostilled by a solicitor/notary public. The following Corporate Documents are required:

- Certificate of Incorporation
- Memorandum and Articles of Association (if your type of company doesn't have memorandum and articles then a similar document which sets out the rules of the company)
- Register of Directors
- Register of Shareholders/Members
- Share Certificate(s)

We can assist you with obtaining the required corporate documents and also with the notarisation and apostille of the documents. Please contact us for assistance.

If the company is older than 1 year, we will require a Certificate of Good Standing. We can assist you with obtaining a Certificate of Good Standing from the relevant authority.

### **Personal Documents Required**

The bank requires the following personal documents from each officer, beneficial owner and authorised signatories within the company:

- Notarised Copy of a valid Passport with the photograph visible
- Notarised Copy of a Utility Bill dated within the last 3 months this can be a Bank Statement, Gas/Electricity Bill
- A reference letter from a bank or certified accountant stating they have know the individual for more than two years

If any of the above documents are not in English, a translated copy must be obtained.

We can assist you with the notarisation and apostille of the required documents, we can also help with obtaining translated documents. Please contact us for assistance.

# **Corporate Documents Required For Corporate Officers**

- Certificate of Incorporation
- Memorandum and Articles of Association (if your type of company doesn't have memorandum and articles then a similar document which sets out the rules of the company)
- Register of Directors
- Register of Shareholders/Members
- Share Certificate(s)

All Due Diligence documents should be in English, if not the documents should be translated into English and certified the same.

### **Currencies Available**

The account can be opened in a number of currencies, including US Dollars, Euro, British Pound, Canadian Dollar and Swiss Francs.

### Visit Required?

A visit to Belize is not required to open this Business Bank Account.

### **Initial Deposit**

The Bank will require an initial minimum deposit of \$3,000 or currency equivalent, before you can have access to your account.

### Timescale

It usually takes around 10 working days for the application to be reviewed and to receive a response on the Account opening.
