## Tax Information for your St Kitts and Nevis Company Registration

No tax if the company is operating outside of St Kitts and Nevis.

if the company is conducting business in St Kitts and Nevis the corporate tax payable annually is 25% of its profits.

## Company Name

When choosing a name for a St Kitts and Nevis Formation the name ending will be Corporation (CORP), Incorporated (INC), Sociedad Anonima (S.A.), Limited or LTD.

## Directors, Shareholders and Secretary

For a St Kitts and Nevis company formation, a minimum of one Director and one Shareholder is required. They can be the same person allowing you to have a 'one man' company. They do not need to reside in St Kitts and Nevis and can be any nationality. Officers of a St Kitts and Nevis Company can also be corporate bodies. You are able to incorporate a St Kitts and Nevis company with a Nominee Director and Shareholder.

## Share Capital

The standard Share Capital is 100 registered shares.

# Annual and Accounting requirements

For a St Kitts and Nevis company registration, it is a requirement that the company registered office address and the registered agent are renewed on a yearly basis - all of these services are included in the CFS annual renewal cost.

The company is also required to file a simple tax-return annually which needs to be filed by the 15th August each year.

## Due Diligence Documents:

To comply with Money Laundering regulations, CFS Formations are required to collect Due Diligence documents for officers within your company.

For a St Kitts and Nevis Incorporation we would require the following documents provided as email copies:

- Notarized copies of two forms of Government issued identification, which must contain the individual's photograph and signature (e.g. Passport, National ID or Driver's License)
- Certified Copy of a Utility Bill e.g., Gas / Electrical or Bank Statement (dated within the last 3 months)
- Professional Reference Letter
- Bank Reference Letter
- Copy of a CV

Please note - in order to release hard copies of the company documents, CFS Formations will require original copies of the above Due Diligence before they are released.

# Business Activities

Most business activities are acceptable in St Kitts and Nevis.

Companies engaging in Crypto Currency are not currently accepted.

If the company will be conducting gambling activities, we will have to confirm whether the business activity is allowed. It is likely that the company will need a licence to conduct such activity in the jurisdiction it will be operating in.
